  - d. On-line metal detectors are incorporated with the capability of detecting ferrous and nonferrous metals down to 2.0 mm.
  - e. Quality Control and Quality Assurance personnel monitor all phases throughout the production processes.

- a. Product is packed in a Burger Maker box with a label bearing the product code, ingredient statement, and packing / portioning information.
- b. Production code dating shall consist of a 6-digit date code. For example: 02/02/03

## 12. MICROBIAL ANALYSIS

Microbiological analysis for TPC (Total Plate Count), and Coliform including E coli 0157:H7 are routinely conducted on all raw materials and equipment by our in-house laboratory.

Burger Maker, inc. manufactures patty products under the FSIS directive 100110.1 Microbial Testing Program for E coli 0157:H7 in raw ground beef. This program guarantee's that any grinding meat utilized for the manufacturing of patty products is tested for 0157:H7 prior to delivery to the production floor. 100% of our raw materials are tested prior to receipt into our facility. Our in house laboratory tests those few whole muscle raw materials not tested prior to receipt.

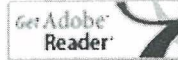

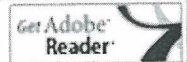
